

Composition

Each L contains Tilmicosin Phospate 250g

Indication

For the treatment of bacterial diseases caused by micro-organisms susceptible to Tilmicosin.

Swine

Pneumonic Pasteurellosis(Pasteurella multocida), pleuropneumonia

(Actinobacillus pleuropneumoniae), Mycoplasma pneumonia

(Mycoplasma hyopneumoniae)

Chickens

Mycoplasmal diseases (Mycoplasma gallisepticum, Mycoplasma synoviae)

Contra-indication

Not for use in animals from which eggs are produced for human consumption

Dosage & Administration

For the treatment of bacterial diseases caused by micro-organisms susceptible to Tilmicosin. Swine

Administer 0.72mL of this drug (180mg as Tilmicosin) diluted with per L of drinking water for 5 days Chickens

Administer 0.27mL of this drug (67.5mg as Tilmicosin) diluted with per L of drinking water for 3~5 days

Packaging unit

100mL, 250mL, 500mL, 1L, 5L

Storage and expiry date

Store in an airtight container at room temperature (1-30°C) protected from light.

24 months from date of manufacture

Precaution

Do not administer to the following animal. А.

Do not use for animals with shock and hypersensitive response to this drug and Macrolide.

Interaction B.

Do not administer with Lincosamide and other macrolide class antibiotics.

- C. Administration for pregnant, lactating, newborn, weanling and debilitating animals. Do not administer to pregnant pig, breeding pigs and laying chickens.

E. Withdrawal period

Swine: 7 days Chicken: 10 days

F. Precaution on storage

Store in a place where out of reach of children and animal to prevent safety accidents.

Observe the preservation instruction since it may bring about a change in effectiveness and stability.

Dispose the expired products without using it.

Use as soon as possible after opening, the rest of it should be sealed in the original packaging container and store it

a dry place protected from light.

Do not use used containers or wrapping paper for other purposes and discard it safely

G. Other Precaution

It is for animal use, so never use it for human.

Consult with your veterinarian.

Use after reading the instruction notes sufficiently

If you are not in compliance with Withdrawal period, that may bring about remaining drugs in animal food, so

accurately calculate and comply with withdrawal period after calculation time

Wear gloves, masks, protective equipment during handling to avoid skin contact and inhalation.

Consult with doctor as soon as abnormality is found.
